- ( ) \$37.50 1. 3.2% BEER BY DRINK: 3.2% non-intoxicating beer for sale at retail by the drink, for consumption on the premises where sold, including Sunday sales and package sales (\$3.13 per month).
- ( ) \$75.00 2. 5% BEER BY DRINK: 5% intoxicating beer for sale at retail by the drink, for consumption on the premises where sold, including Sunday sales from 9:00 A.M. to 12:00 Midnight, and including package sales (\$6.25 per month).
- ( ) \$75.00 3. 3.2% AND/OR 5% BEER BY DRINK & LIGHT WINES: 3.2% and/or 5% beer, and light wines (up to and including 14% alcohol), for sale at retail by the drink, for consumption on the premises where sold, including package sales of beer and wine (\$6.25 per month).
- ( ) \$300.00 4. SUNDAY 3.2% AND/OR 5% BEER BY DRINK & LIGHT WINES: Sunday sales of 3.2% and/or 5% beer, and light wines (up to and including 14% alcohol), for sale at retail by the drink, for consumption on the premises where sold, including package sales of beer and wine (\$25.00 per month).
- ( ) \$450.00 5. FULL LIQUOR: Intoxicating liquor of all kinds for sale at retail by the drink, for consumption on the premises where sold, including the sale of intoxicating liquors in the original package (\$37.50 per month).
- ( ) \$300.00 6. SUNDAY FULL LIQUOR: Sunday sales of intoxicating liquor of all kinds at retail by the drink, for consumption on the premises where sold, including package sales (\$25.00 per month).
- ( ) \$150.00 7. FULL PACKAGE: Intoxicating liquors for sale in original packages only; not for consumption on the premises where sold (\$12.50 per month).
- ( ) \$300.00 8. SUNDAY FULL PACKAGE: Sunday sales of intoxicating liquor in the original package only, between the hours of 9:00 a.m. and 12:00 midnight; not for consumption on the premises where sold (\$25.00 per month).
- ( ) \$75.00 9. 5% PACKAGE BEER: 5% intoxicating beer sold in original package only, not for consumption on the premises where sold including Sunday sales from 9:00 A.M. to 12:00 Midnight (\$6.25 per month).
- ( ) \$25.00 10. TEMPORARY - FULL LIQUOR BY DRINK: Intoxicating liquor of all kinds for sale at retail by the drink, including non-intoxicating 3.2% beer, for consumption on the premises where sold (including Sunday sales after 9:00 a.m.), \_\_\_\_\_, on the following dates only (7 day maximum): \_\_\_\_\_ (only available to non-profit entities).
- ( ) \$37.50 11. ALCOHOLIC BEVERAGE TASTING: Wine, malt beverage and distilled spirit tasting on the premises, not to be sold for on-premises consumption. Must be licensed to sell intoxicating liquor in the original package at retail. License includes Sunday if applicant has a Sunday Package License (\$3.13 per month).
- ( ) \$15.00 12. TEMPORARY CATERER'S PERMIT: Provides for the sale of liquor at a location other than the currently licensed premises (\$15.00 per day or fraction thereof). **A separate Caterer's application is required.**
